## **Apprentice HVAC Installer Residential/Commercial**

### **Summary/objective:**

Apprentice HVAC Installers possess knowledge of heating, ventilation, and air conditioning systems. Installation and service these systems in residential and commercial buildings. Understanding of the various components of each system and testing electrical circuits that supply power to the various systems.

# **Essential functions and Responsibilities:**

- Basic mathematical skills including the ability to read a tape measure.

## **Physical demands:**

- Able to lift at least 50lbs on a regular basis.
- Must be able to operate a vehicle using a seat belt safely and legally
- Must be able to wear appropriate personal protective equipment
- Must be able to twist the trunk of your body 90 degrees in each direction
- Must be able to perform work over head
- Must be able to stand on concrete surfaces for extended periods, routinely up to 4 hours
- This position is highly physical and requires regular use of hands, fingers, walking, stooping, kneeling, and climbing ladders. It requires employees to regularly lift and or move up to 10 lbs. and frequently lift and/or move up to 50 lbs. (may occasionally lift and/or move more than 50 lbs. with special approval.)
- Must be able to safely use a ladder
- Must be able to maneuver access areas, as small as 30" vertical x 45" horizontal
- Must be able to access rooftops comfortably and routinely with extension and/or fixed ladders at heights of 15' to 20', and occasionally, up to 50 feet +
- This role may be exposed to variable weather conditions, moving mechanical parts, heights, risk of electrical shock, noisy operating equipment and other variable environmental conditions based on location
- Willing to submit to drug/alcohol testing at any time, with reasonable suspicion, while clocked into work
